QUALIFICATIONS FOR OFFICE

A person is qualified to be nominated, elected, and to hold office as a member of local government if they meet the following criteria:

- Canadian citizen;
- 18 years of age or older;
- resident of British Columbia for at least 6 months immediately before the day nomination papers are filed;
- a person or the commander of an armed forces unit who has been granted freedom of the municipality, if that person is a Canadian citizen; and
- not disqualified by the *Local Government Act* or any other enactment from voting in an election in British Columbia or from being nominated for, being elected to, or holding office.

OPTIONAL

CAMPAIGN PERIOD EXPENSE LIMITS

In accordance with the *Local Elections Campaign Financing Act*, for the 2018 general local election, the following expense limit for candidates during the campaign period applies:

Office of Mayor: **\$10,000.00**
Office of Councillor: **\$5,000.00**

THIRD PARTY ADVERTISING LIMITS

In accordance with the *Local Elections Campaign Financing Act*, for the 2018 general local elections, the third party advertising limit is **\$750.00**
